Mar 2023 - Present

- Successfully responded to and mitigated over 250 emergency calls in a year, including fires, medical emergencies, and hazardous materials incidents, ensuring public safety and minimal property damage within the community.

- Played a key role in a major multi-alarm fire incident, assisting in the successful evacuation of 15 residents from a burning apartment building and contributing to the containment of the fire within 3 hours, preventing further damage to surrounding structures.
- Improved the department's response time by 10% by proactively participating in apparatus and equipment maintenance, ensuring that all gear was in optimal condition and ready for immediate deployment in emergency situations.
